This year the award is being made in the name of the late Reverend Elizabeth Skinner. Elizabeth was very active in the Rocky Mountain Conference and its predecessor Conferences, as well as the regional and national levels.

If you know of any persons who should apply, please forward these forms to them. Please duplicate the forms as may be necessary. The application forms and additional information must be submitted to the Conference office by May 18, 2007.

In order to continue offering this scholarship we need to attract scholarship funds. Should you know of anyone who would like to make a contribution, please have them send their gift to the Rocky Mountain Conference Scholarship Fund at the Conference Office.

Instructions for completing the scholarship application

1. Application is to be completed by applicant.
2. Please type or print clearly.
3. Attach the following to complete application:
 - a. Three (3) letters of reference.
 - b. Confirmation of membership in a Rocky Mountain Conference UCC congregation, signed by the pastor.
 - c. Current transcript.
 - d. Biographical statement, including educational background, financial need (form attached), special interests, and other pertinent information about your self, i.e. career goals. (All information will be kept confidential.)

GOALS

- A. Because of increasing costs associated with higher education and the monies that have been given to the Conference for scholarships, these funds shall be used for the stated purpose.
- B. At the Rocky Mountain Conference Annual Meeting in June a scholarship will be awarded:
 - on a three-year rotating basis in the name of Elizabeth and Brad Skinner (seminary student), Herbert and Jean Hosanna (undergraduate student), or Richard Cowden (graduate student).
- C. The amount of the scholarship given for the academic year 2007-2008 will be \$1,800.00 to one student, \$900 per semester.

GUIDELINES

- A. The recipient must be a member of a Rocky Mountain Conference UCC congregation.
- B. The recipient shall be enrolled in, or accepted by, an accredited institution.
- C. The applicant must state the amount of need. (This does not mean the need will be met, but it does give some indication that the person has given some thought to the matter.)
- D. The scholarship is for one academic year only.
- E. The expectation is to use only the yield of the Rocky Mountain Conference Scholarship Fund.
- F. Any monies given for scholarships to the Conference will be put into one fund balance of the Rocky Mountain Conference.
- G. The recipient(s) shall be recommended by the Scholarship Committee of the Faith Nurturing Ministries Committee. The committee will be composed of two committee members and one Conference staff.
